ADDITIONAL INFORMATION

*The Early Drop-off Program is for children enrolled in the Half Day Program and allows families to drop-off anytime between 7:30am and 9:00am. After 9:00am, families are expected to wait until class starts at 9:15am. Children enrolled in the Full Day Program may arrive at 7:30am as part of their tuition.

**The Enrichment Activities Program is for children enrolled in the Half Day or Full Day Program, but is limited to certain age groups. For more information on each of the daily enrichment options, families should reference the *OKECC 2019-2020 Enrichment Activities Guide*, which will be available at the time of registration. All children enrolled will have a quiet time and bathroom break from 1:00pm to 1:15pm, and then transition to the applicable activity. Children enrolled in the Half Day Program are to be picked up by 2:30pm. Children enrolled in the Full Day Program will be walked by an educator back to their classroom.

***The Extended Afternoons Program is for children enrolled in the Half Day Program and allows families to pick-up anytime between 1:00pm and 6:00pm (or by the applicable Shabbat closing time on Fridays). Families may register their child(ren) for a maximum of two afternoons per week. Families who would like their child to participate in the Enrichment Activities Program on the same day their child is signed up for the Extended Afternoons Program, must sign up separately for the applicable enrichment as directed in the registration instructions. The Extended Afternoons Program may not be available every weekday or for all age groups; availability depends on class enrollments and families interested in the Full Day Program are given priority for afternoon spaces.

PROGRAM OPTIONS POLICIES

Registration for Ohr Kodesh Early Childhood Center (OKECC) program options varies by program. Families may register their child(ren) for the Early Drop-off Program at the time they register for the school year. Registration for the Enrichment Activities and Extended Afternoons Programs opens in later August and is completed via a separate form. Families may also register their child(ren) in one or more OKECC program options at any point during the year, and the annualized fee will be prorated as applicable. Space, however, is limited for all program options and cannot be held/guaranteed. If a program option is filled, a waitlist will be maintained.

In the event a family decides to withdraw their child from the Early Drop-Off or Enrichment Activities Programs, two weeks written notice to the OKECC Director or OKECC Assistant Director must be provided and the child's associated program costs for those remaining two weeks will be due regardless of attendance.

In the event a family decides to withdraw their child from the Extended Afternoons Programs, four weeks written notice to the OKECC Director or OKECC Assistant Director must be provided and the child's associated program costs for those remaining four weeks will be due regardless of attendance.
